Release of Liability and Assumption of Risk Waiver Form for Run Wild Trail Camp

*By completing and signing this contract you acknowledge that you agree to and understand the terms and conditions herein. You are waiving certain legal rights, including the right to sue Run Wild Trail Camp, its organizers, directors, volunteers, representatives and members. Please read this contract carefully.*

You, the participant(s), acknowledge that participation in any hiking activity organized by Run Wild Trail Camp (RWTC) carries with it inherent risks including, but not limited to, the risk of injury or death. And you, the participant(s), freely accept and fully assume all such risk(s). It is the responsibility of each participant of a hike to familiarize themselves with the risks of hiking, to weigh those risks against the advantages, and to decide whether or not to participate. Run Wild Trail Camp organizers and volunteers cannot and will not assume liability in respect of any of these risks, dangers, hazards and liabilities. Participants further acknowledge that it is their responsibility to ensure that they carry adequate medical, extended health, dental and accident insurance coverage, as well as protection for personal possessions. It is the participants individual responsibility to verify that they are in good health and are physically capable of carrying out the hiking activity or any activity organized by Run Wild Trail Camp.

I am aware that the volunteers and coordinators of Run Wild Trail Camp, acting as trip coordinators of activities, are not professional leaders, guides, or licensed first aid attendants. I am aware that the volunteer coordinators may not have completed an outdoor leadership course or have first aid ( including wilderness) training or experience in either and are not responsible for my safety or that of any children I bring while participating in such activity. I am aware that other participants with me in the activity are not responsible for my safety or that of any children I bring.

I acknowledge that Run Wild Trail Camp is not responsible for providing transportation to and from the activity location and that I may have to make my own private arrangements for my transportation. If I participate in car pooling with other participants in the particular event, then I do so entirely at my own risk and without any right to claim against Run Wild Trail Camp for any loss, damages, or personal injury whatsoever I may suffer. I agree to assume all of the risks and responsibilities associated with my transportation to and from the activity location.

This is a free, organized activity. There are no paid guides. Organizers plan trips and allow families to come on their own free will. Everyone is responsible for their own actions and we hike together as would a group of friends. We will watch out for each other and take care of each other as best we can.

Therefore, in consideration of being allowed to participate, individuals release Run Wild Trail Camp, and it's organizers and volunteers from all liability in respect of any personal injury suffered, any damage or loss of personal property, which may arise out of participation in a hiking club activity.
